## What do we do?

- provide a range of training to professionals from raising awareness to in depth information about meeting a pupil's needs (see our training leaflet)

- provide advice to educational settings
- assess pupils' needs - specific to sensory impairment and including language assessments, functional vision assessments, IT assessments, etc.
- provide direct teaching of specialist skills
- provide opportunities for wider participation
- contribute and promote multi agency working practices
